1---4 2 FWD 2 STEPS;; 2 RIGHT TURNS;;
1-2 Semi Fwd L, Close R, Fwd L,-; Fwd R, Close L, Fwd R,-;
3-4 Blend to CP Wall Side LOD L, Close R, Turn Rt Face on L,-;
Continue Turn Side R, Close L, Turn Rt Face on R, Blending to
Semi LOD -;
5---8 2 FWD 2 STEPS;; DOUBLE HITCH 3;;
5-6 Semi Fwd L, Close R, Fwd L,-; Fwd R, Close L, Fwd R,-;
7-8 Fwd L, Close R to L, Bk L,-; Back R, Close L to R, Fwd R,-;
9---16 2 FWD 2 STEPS;; 2 RIGHT TURNS;; 2 FWD 2 STEPS;; DOUBLE HITCH 3;;
Repeat Measures 1 thru 8 of Part A;;;;;;
17 SIDE, DRAW, CLOSE,-;
17 Face Partner & Wall in Bfly Side LOD L, Draw R to L, Close R,-;
Completed by lowering trailing hands as you draw, on
Close straighten up.

PART B

1---4 FACE TO FACE: ROCK THRU, RECOVER; FACE TO FACE; ROCK THRU, RECOVER;
1-2 In BFLY Side LOD L, Close R, Side L,-; Turn to OPEN LOD Rock
thru R,-, Recover L to Face Partner,-;
3-4 Repeat measures 1 & 2 going RLOD;;
5---8 FULL BOX in BFLY;; CHANGE SIDES, 2, 3; PAGE, 2, 3;
5-6 In BFLY Side LOD L, Close R, Fwd L,-; Side R, Close L, Back R,-;
7-8 Under M's Left & W Right Hand Change side L, R, L,-; Continue
to face partner R, L, R,-;
9 SIDE, DRAW, CLOSE;
9 Face Partner & COH in BFLY Side LOD L, Draw R to L, Close R,-;
Completed by lowering trailing hands as you draw, on the
Close straighten up.
10-18 REPEAT ALL OF PART B 1 thru 9 Man on OUT SIDE CIRCLE GOING RLOD
10-18 With MAN facing COH start by moving RLOD REPEAT measures
1 thru 9 of part B;;;;;;
